

Social Media Influencer Stargazing Box Giveaway Official Rules

- <u>1. Registration Period:</u> The giveaway period begins at 11:00 A.M. EST on Tuesday, September 5, 2023, and ends at 2:00 P.M. EST on Monday, September 11, 2023 ("Registration Period").
- **2. Sponsorship:** General R.V. Center, Inc., 25000 Assembly Park Dr., Wixom, MI 48393 is the sponsor of this Giveaway. It is referred to in these rules as "General RV," "GRV," or "Sponsor."
- <u>3. Host:</u> stairsuphandlein, Jen Reinhart, will be referred to as "Host." The Host will announce the "Giveaway" on their Instagram or TikTok Page. Entries will be made on that Instagram or TikTok post, and Sponsor will choose the winner at random from qualified entries as described in these Official Rules.
- <u>4. The Giveaway:</u> The Host will create and post an Instagram or TikTok video displaying a General RV Stargazing Story Box to their followers. Participants will follow the entry requirements described in these Official Rules. Sponsor will track entries and choose one (1) winner at random. Sponsor will notify the winner by tagging them in the comment section.
- **5.** To Enter: To enter, participants must: 1) follow the Host on the social channel of entry, Instagram or TikTok; 2) follow General RV Center on the social channel of entry, Instagram or TikTok; and 3) Tag a Friend in the post's comment sections. No purchase is necessary, and the purchase of anything from GRV will not increase the chance of winning.
- <u>6. Eligibility:</u> This Giveaway is open to legal residents of the contiguous United States of America, who enter the Giveaway on Host's Instagram/TikTok video post. Entrants must be 18 years of age or older as of their date of entry in this Giveaway to qualify, and they must be a natural person living in the United States. Anyone using or attempting to use a robot, Artificial Intelligence, or other inappropriate means to enter or win this Giveaway is not eligible. Under no circumstances may a person be entitled to more than one prize. The actual prize may differ at the time the prize is awarded. The prize will be determined solely by the Sponsor. No cash or other prize substitution is permitted, except at the Sponsor's discretion. The prize is non-transferable. Winner, upon acceptance of the prize, is solely responsible for all expenses related to the prize, including without limitation all local, state, and federal taxes.
